Prepare for employment in the electrical and carpentry trades! Individuals 16-29 years old may be eligible for this **FREE** program which prepares participants for entry level employment in trades positions.

Trades Exploration will be delivered in partnership with Vancouver Island University. There will be a two week carpentry component as well as a two week electrical component. Earn industry recognized certifications including Occupational First Aid Level 1, WHMIS, Fall Protection, Confined Space Training and more.

This program starts September 25, 2023 and includes 8 weeks of classroom training (Monday - Friday) and 4 weeks of PAID onsite work experience.

Every September, B.C. Disability Employment Month highlights the significant role people with disabilities play in B.C.'s workforce. People with disabilities can discover supportive services to help build their careers. Between April 2022 and March 2023 WorkBC supported over 4,600 people with disabilities through their first year of employment.

Benefits and Credits for Adults 65 years and older

 Benefits, credits and deductions you could be eligible for are the Disability Tax Credit, GST/HST credit, medical expenses, Canada caregiver credit and pension income splitting. If you do your taxes after the filing deadline, your payments could be delayed.

StrongerBC Future Skills Grant

The StrongerBC future skills grant is open to British Columbians aged 19 years or older – regardless of financial need – and covers up to \$3,500 per person for eligible short-term skills training at public post-secondary institutions.
